- Knowledge and experience of advising on fuel / bunker disputes (desired)
- You will have excellent drafting skills
- You will be used to taking on a high degree of responsibility for the cases that you work on
- You will be motivated, enthusiastic and able to thrive in a fast-paced working environment
- You will relish client contact, with strong business development and client engagement skills
- You will also be expected to play an active role in practice and business development, including
 writing articles and briefings for HFW publications / clients in relation to the Sustainable
 Maritime Legal Transport practice
