# LATAM ENTRY REQUIREMENTS AND VACCINATION STATUS


LATAM entry requirements as of 7 July 2021\*

COUNTRY	ENTRY REQUIREMENTS
Argentina	<p>Most foreigners, who are not a resident in Argentina, will not be permitted to enter Argentina. Curfew in place from 00:00 p.m. until 6:00 a.m.</p> <ol style="list-style-type: none"> <li><b>NEGATIVE COVID-19 PCR TEST TAKEN WITHIN 72 HOURS BEFORE TRAVEL</b></li> <li><b>ALL PASSENGERS ARRIVING IN ARGENTINA WILL BE REQUIRED TO UNDERGO A COVID-19 PCR TEST ADMINISTERED BY LOCAL HEALTH OFFICIALS.</b> In the event that the requested entry is denied, the passenger will be ordered to depart on the next available flight or means of transport</li> <li><b>10-DAY QUARANTINE</b> from the date of the negative PCR test.</li> <li>Persons returning to the City of Buenos Aires by private vehicle may be required to obtain a Covid-19 test within 24 hours of arrival at city-designated locations.</li> </ol>
Belize	<ol style="list-style-type: none"> <li><b>PROVIDE PROOF OF HAVING RECEIVED TWO FULL DOSES OF COVID-19 VACCINE TWO WEEKS BEFORE ARRIVAL, OR</b></li> <li><b>NEGATIVE PCR TEST CARRIED OUT 96 HRS PRIOR TO TRAVEL</b> or <b>RAPID ANTIGEN TEST HRS PRIOR TO TRAVEL</b></li> <li>Upon arrival, <b>RANDOM SECONDARY TESTING</b>, except: proof of having received two full doses of COVID-19</li> </ol>
Brazil	<ol style="list-style-type: none"> <li><b>TRAVELER'S HEALTH DECLARATION</b></li> <li><b>NEGATIVE PCR TEST CARRIED OUT 72 HRS PRIOR TO TRAVEL</b>, except: <ul style="list-style-type: none"> <li>Children under the age of twelve, who are travelling with a companion</li> <li>Children under 2 years of age</li> <li>Flight crews provided they follow special guidelines</li> </ul> </li> </ol>
Chile	<p>Only Chilean citizens and foreign residents of Chile may enter Chile. The borders will remain closed until July 14. There is a daily curfew from 10:00 pm to 5:00 am, nationwide.</p> <ol style="list-style-type: none"> <li><b>COMPLETE "AFFIDAVIT OF TRAVELLERS"</b></li> <li><b>PROOF OF A HEALTH INSURANCE POLICY</b>, with coverage for COVID-19</li> <li><b>NEGATIVE PCR TEST FOR COVID-19 CARRIED OUT 72 HRS PRIOR TRAVEL</b></li> <li><b>10-DAY QUARANTINE</b> (mandatory)</li> </ol>
Colombia	<p>The borders with Panama and Ecuador remain closed. Travellers coming from India are prohibited from entering.</p> <p>Various cities in Colombia are instituting curfews, based on ICU capacity.</p> <p>No tests results are required.</p>
Costa Rica	<ol style="list-style-type: none"> <li><b>COMPLETE ONLINE THE HEALTH PASS</b></li> <li><b>TRAVEL INSURANCE</b> (mandatory)</li> </ol>
Dominican Republic	<p>No tests results are required, however, rapid tests are performed on randomly selected travellers upon arrival. Since 3 March, a nationwide curfew has been in place.</p>
Ecuador	<ol style="list-style-type: none"> <li><b>NEGATIVE COVID-19 RT-PCR</b> or <b>RAPID ANTIGEN TEST TAKEN NO MORE THAN THREE DAYS BEFORE TRAVEL</b>, except: (1) airline crew; (2) children age two and under; (3) fully vaccinated travellers, who will present a vaccination card; and (4) travellers previously diagnosed as COVID positive, but with more than one month since the onset of symptoms, may present a medical certificate from their country of origin attesting to their recovery and current good health.</li> </ol>

\* The entry requirements are changing regularly.

COUNTRY	ENTRY REQUIREMENTS
El Salvador	(1) <b>NEGATIVE PCR TEST CARRIED OUT 72 HRS PRIOR TO TRAVEL</b> , expect passengers showing a proof of completed vaccination
Guatemala	<p>Foreigners who have visited <b>Brazil, the United Kingdom</b> or <b>South Africa</b> within the past 14 days are <u>not permitted to enter</u>.</p> <p>(1) <b>NEGATIVE COVID-19 PCR OR ANTIGEN TEST RESULT WITHIN 72 HOURS PRIOR TRAVEL</b>, expect: passengers showing a proof of completed vaccination at least two weeks before arrival, or a proof of recovery from COVID-19 within three months of arrival.</p>
Guyana	<p>Guyana has a nationwide curfew from 10:30 p.m. until 4:00 a.m.</p> <p>(1) <b>NEGATIVE PCR TEST RESULTS MUST BE SUBMITTED ELECTRONICALLY AT LEAST 24 HOURS BEFORE ARRIVAL</b>. If test results are more than 72 hours old upon flight departure for Guyana, the traveler must be re-tested at the airport.</p>
Honduras	<p>Non-resident Honduran citizens and tourists coming from <b>the United Kingdom</b> or <b>South Africa</b> or having visited or transited through those areas in the last 21 days are restricted from entering.</p> <p>Honduras has a curfew from 10:00 p.m. until 5:00 a.m.</p> <p>(1) <b>COMPLETED ONLINE PRECHECK FORM</b>  (2) <b>NEGATIVE PCR TEST</b></p>
Mexico	<p>Non-essential travel along the U.S.-Mexico land border is restricted at least until 21 July 2021.</p> <p>Local curfews in place. Restrictions vary based on state and/or city.</p> <p>A negative COVID-19 test is not required for entry.</p>
Nicaragua	(1) <b>NEGATIVE PCR TEST</b>
Panama	<p>Effective 3 May 3 2021, travellers who have been in or who transited through <b>the United Kingdom, India, South Africa</b> or <b>any country in South America</b> must provide proof of a negative COVID test within the last 48 hours. These travellers will also undergo molecular testing upon arrival.</p> <p>Local curfews in place. Restrictions vary based on state and/or city.</p> <p>(1) <b>NEGATIVE PCR OR ANTIGEN TEST RESULT WITHIN 48 HOURS PRIOR TRAVEL</b>. •If not tested, or the test was done more than 48 hours before travelling to Panama, passengers are required to take a test at the airport.  (5) <b>COMPLETED ELECTRONIC SWORN AFFIDAVIT</b> prior to check-in.</p>
Paraguay	<p>Curfew in place between 20:00 pm and 05:00 am.</p> <p>(1) <b>NEGATIVE RNA TEST (RT-PCR, NAAT, OR NAAT) TAKEN NO MORE THAN 72 HOURS PRIOR TO ENTERING THE COUNTRY</b>.</p> <p>(2) <b>7-DAY QUARANTINE</b> if travellers are coming from <b>Brazil</b>, addition to the pre-entry test</p> <p>(3) <b>INTERNATIONAL MEDICAL INSURANCE</b></p> <p>(4) <b>COMPLETED THE MINISTRY OF HEALTH'S FORM</b></p>
Peru	<p>Entrance of non-resident passengers travelling from <b>Europe, Brazil, India</b> or <b>South Africa</b> (or travellers who have transited there in the last 14 days) is suspended.</p> <p>Local curfews in place.</p> <p>(1) <b>NEGATIVE REAL-TIME COVID-19 MOLECULAR (RT-PCR), NEGATIVE ANTIGEN TEST RESULT, or A MEDICAL CERTIFICATE OF EPIDEMIOLOGICAL DISCHARGE</b> that is no more than <b>72 HOURS OLD</b> after being issued and before boarding the plane.</p>
Puerto Rico	<p>(1) <b>COMPLETED TRAVEL DECLARATION</b></p> <p>(2) <b>PROOF OF BEING FULLY VACCINATED WITH THE MODERNA, PFIZER OR JANSSEN VACCINES, OR MUST PROVIDE EVIDENCE OF A NEGATIVE MOLECULAR OR ANTIGEN TEST FOR COVID-19 PERFORMED WITHIN THE 72-HOUR PERIOD PRIOR TO YOUR ARRIVAL</b>. Any passenger arriving without a PCR test result will get a USD 300 fine.</p>
Uruguay	<p>Uruguay's airports and borders are closed to nonresident foreigners.</p> <p>(1) <b>NEGATIVE PCR TEST RESULTS, CARRIED OUT UP TO 72 HOURS BEFORE THE START OF THE TRIP</b></p> <p>(2) <b>AFFIDAVIT STATING THE ABSENCE OF SYMPTOMS</b></p> <p>(3) <b>MEDICAL INSURANCE WITH SPECIFIC COVERAGE FOR COVID-19</b></p>
Venezuela	(1) <b>NEGATIVE COVID-19 PCR TEST PERFORMED WITHIN 48 HOURS OF BOARDING THEIR INCOMING FLIGHT</b> . All individuals will be subjected to a further COVID-19 PCR test at port of entry
