

This includes matters arising from major casualties, natural disasters, war, terrorism, political risks, detention, kidnap for ransom, special risks and other challenging events.

Exposure in complex and hostile environments

Hostile and complex environments present inherent physical challenges. Additionally, legal, regulatory and reputational risks are pervasive, and present real difficulties.

Incidents in hostile and complex environments commonly result in actual or threatened legal actions, including multi-jurisdictional litigation and arbitration.

The team advises on structuring and organising the response to an incident to protect our clients' interests in the short, medium and long term. This includes anticipating, identifying and mitigating liabilities and exposures potentially arising from the incident.

The team deals with contractual liability disputes, non-contractual tort claims from third parties who may be owed a duty of care – including volume claims arising from major incidents - employment and contractor liabilities for deployed personnel, and business interruption losses. This includes investigating and pursuing recovery actions from third party wrongdoers.

The team is often called upon to manage and mitigate actual or anticipated intervention by authorities, including in areas involving criminal, regulatory, health & safety, sanctions, and human rights violations.

The Complex Environments Specialists work in conjunction with HFW's Global Investigations and White Collar Defence Specialists in regulatory and criminal investigations.

In high-risk operating environments, companies are under increased scrutiny and pushed to demonstrate their adherence to standards and duties of care. This demands that evidence is collected and preserved to high evidential and chain of custody standards, to reduce exposure to legal risks.

Evidence Service

In response to this increased legal risk, companies need to comprehensively protect themselves following an incident in a hostile or complex environment.

Our evidence Specialists provide a front-line response to protect our clients' interests following an incident in a hostile or complex environment. Their expertise includes:

Immediate Response: Following an incident, our Specialists can urgently deploy to the scene and conduct urgent real time on-the-ground investigations. This ensures that critical evidence is secured without delay, and we can provide advice to enable immediate decision making on incident resolution issues.

Our Specialists can be dispatched anywhere on behalf of a client, venturing into areas where other legal professionals might hesitate. Our Specialists can travel internationally, often at extremely short notice, and remain away for extended periods, tailoring their presence to meet our clients' specific requirements.

- On-Site Evidence Collection and Preservation:
 By urgently attending the scene of an incident, our
 Specialists can ensure that critical evidence is secured
 and preserved without delay. Once dispatched, our
 Specialists gather evidence on-site to protect our
 clients. Such evidence might include:
- Physical evidence documents, security logs, photographs, hard/data drives, phones and other relevant evidential material;
- Contemporaneous communications such as emails, texts, phone messages, social media, logs:
- Witness statements all relevant witnesses can be interviewed to provide crucial firsthand accounts while memories are fresh. Given the transitory nature of many employees/ contractors engaged in hostile and complex environments, it is often important to capture such evidence at an early stage;
- Evidential standards we collect witness evidence in a manner which will be compliant with court requirements regarding witness evidence (ensuring its future utility in any adverse legal proceedings); and
- Real-time evidence we can conduct urgent real-time on-the-ground investigations providing advice to enable immediate decision making on incident resolution issues.

Our Specialists' ability to collect / preserve evidence directly at the scene, coupled with meticulous preservation techniques, is invaluable to protecting our clients' interests following an incident.

 Investigations: Our Specialists can conduct thorough investigations into the specific circumstances and causation of an incident. By collecting / preserving evidence at an early stage and by analysing that evidence, we provide our clients with an increased chance of understanding what happened, what their legal exposure might be, and how best to manage it.

Managing the incident in contemplation of litigation by creating audit trails and contemporaneously securing and preserving documents and witness evidence. Conducting after the event investigations / after action reviews to protect and safeguard our clients, so that they are well equipped to deal with future multi-jurisdictional legal disputes, government/regulatory/criminal investigations and interventions.

 Engagement with Authorities: our Specialists commonly engage with law enforcement, public prosecutors, public investigators, government agencies, diplomats and the military, when responding to an incident and have a repertoire of global contacts commensurate with a law firm that has been engaged in crisis management worldwide for over 125 years.

Who are our Specialists?

Our Specialists consist of experienced commercial litigators with extensive global litigation experience, technical experts, ex-military personnel with combat experience, former government employees, and media experts – all drawn from our global network.

Our Specialists are experienced at handling sensitive matters, where the careful handling of victims or witnesses is required. Many of our Specialists have undergone Trauma Risk Management (TRiM) training which allows them to be vigilant towards the psychological effects often experienced by those who have suffered a traumatic event (such as injury, kidnapping or detention). This training allows them to identify potential psychological issues and recommend further expert assistance, if required. This proactive approach can result in the lessening of harm to the individuals and, therefore, to the minimising of further legal exposures to clients (from psychological injury claims).

Legal privilege and our Specialists

Our Specialists undertake investigations with the protection of legal privilege / client-attorney privilege – a critical advantage over using a company employee or a third-party non-lawyer.

This ensures that certain evidence (for example, witness statements and expert evidence) can remain privileged and not subject to discovery / disclosure in future court proceedings.

Moreover, by collecting evidence early and under the protection of legal privilege / client-attorney privilege, we establish a strong foundation, as evidence custodians, to manage, develop and respond to all future issues and disputes.

Our Specialists are uniquely qualified to handle evidence collection to the standards required in complex litigation. They know what evidence is relevant, admissible, and legally significant. We can prioritise confidentiality, strategic control, and informed decision-making.

Our guidance protects our clients from inadvertently damaging their case by mishandling evidence or violating legal rules.
