O-1 Extraordinary Ability Visas

We examine your foreign national talent with an eye for what makes them special and highly beneficial to business operations. U.S. employers are subject to very tight H-1B specialty occupation quotas that exclude the majority of degreed talent from having a chance at working in the United States. This O-1 extraordinary ability examination and subsequent

petition preparation gets the “superstars”, experts and highly coveted professionals on board with your company, when you need them. This is a highly valuable service that requires understanding the needs of your company and why this person is vital to its future. Our team has guided hundreds of individuals to approval that have allowed them to grow their businesses in numerous areas such as tech, science and engineering.

E-2 Treaty Trader/ Investor Visas

Many foreign owned and foreign controlled United States companies can qualify for this visa when their country has signed a qualifying international agreement or treaty with the United States. This visa avoids the harsh quotas of other visas and allows only nationals of that treaty nation to obtain a visa when they are owners, managers, executives and specially qualified individuals who are vital the creation or continuation of a United States business.

L-1 Intracompany Transfers of Executives, Managers and Specialized Knowledge Individuals

These visas are among the most highly scrutinized visas under United States immigration laws. They allow for the transfer of valuable personnel from their locations abroad to be

able to serve the building, expansion or continuation of United States companies. This visa also allows future options for the permanent residence of these talented professionals. We guide companies on weighing the risks of applying for this visa and offer other options for consideration that may fit company and economic circumstances.

H-1B Specialty Occupation Visas

Degreed individuals must be chosen in the annual H-1B visa lottery to be able to work for United States companies. They must be working in the areas directly connected to their degrees or equivalent experience. We make the examination that the worker qualifies under the H-1B regulations and that they are paid the required wage of their geographic location.

TN Visas for Canadian and Mexican Professionals

The U.S.-Mexico-Canada Agreement was signed into law in January of 2020, leaving the TN professional visas for Canadians and Mexicans intact. Companies can continue to use these options to gain the faster work authorization for professionals in numerous areas including engineering, accounting, computer systems analysis, architecture and those working in the sciences.
